- Rates, programs, privileges are valid for 2020 season
- Season runs from approximately April 1-November 20 weather permitting
- Rates are non-negotiable
- Passes are non-transferable and non-refundable
- Pass-holder dues must be paid in full at time of registration
- Tee times may be booked up to 7 days in advance
- Tee times subject to course availability
- Pass-holders are required to check-in prior to tee time and before every round
- Pass-holder privileges may be suspended or revoked at anytime for inappropriate or unacceptable behavior



- Dress code must be followed
- Passes are not valid for golf outings
- League participation shall be allowed at no additional charge
- Special events are available for pass-holder participation at designated fees posted for each event
- Golf carts are rented on a round by round basis

- 2 membership appreciation days per season (weather permitting)
- 10% discount on in stock, non sale merchandise in proshop (excludes Ping)
